



TV Series Production – Information & Details for Location Filming in Exshaw / Bow Valley

March 15, 2024

Please take a moment read this notice about filming activity in Exshaw/Bow Valley between March 18th and 26th. We would like to provide you with information that will help you prepare for this special event and anticipate how it may affect your daily routine. The following is an outline of the filming dates, approximate times and significant action.

March 18th to March 26th, approximately 7:00am – 7:00pm each day

• A crew of technicians will be working at Mt Allen Dr, Exshaw preparing the street for filming

March 21st to March 24th, 24 hours each day

- Hwy 1A between Grotto Pond and Lafarge, will be closed to all vehicle traffic starting 04:00 AM on Thursday March 21st and remain closed until the evening of Sunday March 24th
- During this period, the approved detour route will be along Hwy 1 and 1X. Access to <u>all</u> residences and businesses remain open at all times. For more information on the detour, see the reverse page
- Mt Allen Dr will be closed to traffic starting at 07:00 AM on Thursday March 21st until the morning of Monday March 25th
- A team of special effects technicians will cover Mt Allan Dr with snow
- Access to Exshaw School will not be impeded, Yamnuska Dr. will be used as a detour route behind the Fire Hall Saturday March 23rd
 - Snow and set dressing on Mt Allen Dr is completed for filming
 - Work trucks will move into the area in the evening and remain parked overnight

Sunday March 24th

- Mt Allen Dr will remain closed for filming; work trucks will leave the area once filming is completed
- Hwy 1A re-opens to traffic

March 25th - 26th

- Snow removal and clean-up at Mt Allen Dr. continue until completed
- Clean up and removal of sets and snow

We emphasize that changes in normal traffic flow are temporary, and appreciate your cooperation during this time. We will ensure special needs are accommodated promptly.

INFORMATION ON CLOSURE AND DETOUR ROUTE



Hwy 1A between Grotto Pond and Lafarge will be closed to traffic starting at 4:00 am on Thursday, March 21st, and will remain closed until evening of March 24th. Weather will not affect our work schedule.

During this period, the approved detour route, as sanctioned by Alberta Transportation, will be along Highway 1 and 1X. This closure will inevitably add travel time to your journey.

Travel time from Exshaw to Canmore along the detour will add approximately 10-12 minutes to the journey, resulting in a total travel time of 24 minutes one way. We recognize the inconvenience this temporary road closure may bring to your daily schedules. Please know that we truly appreciate your flexibility and understanding as we work to complete the project on the highway.

We have collaborated closely with various stakeholders, including Lafarge, Baymag, Graymont, MD of Bighorn, Stoney First Nations, Canadian Rockies Public Schools, Exshaw School, Town of Canmore, Fire & Emergency Services, CP Rail and of course Alberta Transportation and Economic Corridors.
